He is also Vice Chairman of the Fisher House Foundation, which constructs homes to house families of hospitalized military personnel and veterans, and is spearheading the efforts of the Intrepid Fallen Heroes Fund, which provides contributions to families of military personnel that have died in the line of duty.

Accepting the award for Fisher will be his son Kenneth Fisher, also an executive with the firm.

Kenneth Fisher said. "We've been fortunate to be honored by groups but there is nothing that makes him more proud than to be honored by the New York real estate community. This is the icing on the cake."

In 2005 Fisher became an Honorary Knight of the British Empire in recognition of his contribution to the welfare of the families of British Armed Forces personnel killed in the line of duty. He is also involved in the Veterans Bedside Network and the Vietnam Memorial in Westchester.
